

**GENERAL RULES AND CONDITIONS OF THE AUCTION**

**REGISTRATION:** NO ONE UNDER THE AGE OF 16 YEARS IS PERMITTED ON THE AUCTION YARD.

**\*\*ANYONE WISHING TO BID ON ITEMS IN THE AUCTION SHOULD REGISTER IN THE NAME THAT THE VEHICLE WILL BE TITLED IN. NO CHANGES CAN BE MADE ONCE YOU HAVE REGISTERED. REGISTRATION IS THREE HUNDRED DOLLARS PER PERSON. ANYONE CAUGHT EXCHANGING THEIR BIDDER CARD WITH ANYONE WHO HAS NOT PAID THE FEE, WILL LOSE THEIR DEPOSIT IN ITS ENTIRETY, \*\*NO EXCEPTIONS\*\*.** THE AUCTIONEER RESERVES THE RIGHT TO REJECT/CANCEL THE BID OF ANY ITEM WITHOUT NOTICE.
